- GENERAL DATA

Public Enterprise (PE) “Kosovo Energy Corporation JSC” (KEK JSC), with headquarters at Mother Teresa Square, No. 36, was established by a Shareholder Decision - Kosovo Trust Agency (KTA), dated 22.12.2005.

In accordance with the Law on Business Organizations (LBO), the enterprise was registered on 22.12.2005 under business no. NRB: 70325399, and Unique Identification Number: 811290808.

The enterprise operates as a Joint Stock Company (JSC), with tax identification number 330051805/ fiscal number 60026259, while its headquarters is located in Prishtina - Kosovo.

The activity code is 3511, which includes the production of electricity.

The ownership structure is one hundred percent (100%) public, while the registered share capital is twenty-five thousand (25,000.00) euros.

- ON PUBLIC ENTERPRISE (PE)

For the needs of the transformation of the enterprise, on 30.11.2005, the evaluation of the enterprise “KEK” JSC (Corporate Project) was carried out.

On 22.12.2005, the Shareholder decided that the capital of the enterprise in the amount of 25,000 euros.

On the same day, the enterprise was transformed into a Joint Stock Company (JSC) with a single shareholder, operating in this form even today.

The founder and sole owner is the Government of the Republic of Kosovo (GRK), which exercises the functions of the Shareholders Assembly in accordance with the law.

- MAIN ACTIVITY

The main activity of the company is the production of electricity.

The company is also engaged in the extraction of hard coal (as a secondary activity) and other activities, such as: Lignite extraction, electricity trade, etc., as well as other auxiliary activities that support its functioning and founding purpose.

2. KOSOVO TELECOM (KT) JSC

- GENERAL DATA

According to UNMIK Regulation No. 1999/12 of 14.10.1999, the Post and Telecommunications Enterprise of Kosovo (PTK) is authorized to provide postal and telecommunications services.

In 2005, UNMIK Regulation 2005/18 of 22.04.2005 authorized the Kosovo Trust Agency (KTA) to transform Publicly Owned Enterprises (PEs) into corporations. According to the administrative authority granted to it by this Regulation, the Kosovo Trust Agency (KTA) incorporated PTK into a Joint Stock Company (JSC) on 28.06.2005

With the Decision of the Government of the Republic of Kosovo (GRK) No. 16/53, on 21.12.2011, the Kosovo Post unit was separated from PTK Sh. A and the Central Public Enterprise (CPE) "Kosovo Post" Sh. A was established.

By Government Decision No. 08/39 dated 22.07.2005, the Public Enterprise (CP) "Kosovo Telecom" Sh. A operates under this name (according to the request of the Board of Directors to change the legal name of the Company from "PTK" Sh. A to "Kosovo Telecom" Sh. A).

Based on the process of transformation of PTK into PTK JSC, the enterprise "Post Telekom i Kosovës Sh. A" was registered on 28.06.2005, with the unique identification number 811288001.

The enterprise operates as a Joint Stock Company (JSC), with tax identification number (fiscal) 600016762, while its headquarters are located in Prishtina 10000, Dardania pn., Kosovo.

The main activity code is 6110, which includes cable telecommunications activities.

The ownership structure is one hundred percent (100%) public, while the registered share capital is 5,000,000 (five million) euros.

- ON PUBLIC ENTERPRISE (PE)

In 2005, the enterprise with the name "PTK" JSC was transformed into a Joint Stock Company (JSC) with a single shareholder, while with the Government Decision 08/39 dated 22.07.2015, it was transformed into a Joint Stock Company (JSC) with a single shareholder, changing the name of the Corporation to "Telekom of Kosovo" Sh. A, and in this form it still operates today. For the needs of the transformation of the enterprise, on 16.10.2009 a certificate for the assessment of the enterprise "Post and Telecommunication of Kosovo (PTK) Sh. A" was issued, in which case the capital of the enterprise was determined in the amount of 5,000,000.00 euros. The founder and sole owner is the Government of the Republic of Kosovo (GRK), which exercises the functions of the Assembly of Shareholders in accordance with the law.

- MAIN ACTIVITY

The company's main activity is Telecommunications.

The company provides mobile and fixed network services, as well as other ancillary activities that support its functioning and founding purpose.

The Chief Executive Officer (CE) of the company is Ms. Burbuqe Hana

According to the business information in the Business Registration Agency – ARBK, the authorized capital is five hundred and twenty-five thousand (525,000.00) euros

Since its establishment according to Decision No. 16/53, dated 21.12.2011, the enterprise has been formed as a Joint Stock Company (JSC) with a single shareholder, operating in this form even today.

The founder and sole owner is the Government of the Republic of Kosovo (GRK), which exercises the functions of the Shareholders’ Assembly in accordance with the law.

On the same day, with Decision No. 05/110, the company was transformed into a Joint Stock Company (JSC) with a single shareholder, operating in this form even today.

The founder and sole owner is the Government of the Republic of Kosovo (GRK), which exercises the functions of the Shareholders' Assembly in accordance with the law.

- MAIN ACTIVITY OF - PE “TRAINKOS” JSC – KOSOVO RAILWAYS (KR)
