#### **Background Paper on EE – in Kosovo**

Kosovo is in the process of European integration - Chapter – Energy

#### **EU Directives on Energy Efficiency (EE)**

<u>Directive 2006/32/EC</u> deals with end energy consumers and Services using the energy.

Kosovo is a member of the Energy Community Treaty of South East Europe, is committed to have transposed this Directive in its legislation and have approved its NEEAP for energy savings at the level of 9% of total energy consumption until the end of 2018, as well as the First NEEAP 2010-2012. Immediately after transposition of this Directive, Kosovo has adopted and approved AI on Promotion of EE of end-consumers and Services using the energy.

<u>Directive 2010/30/EC</u> deals with Labelling of appliances which use the Electricity Energy. In order to comply with this Directive, Kosovo has adopted and approved AI on appliances which use the Electricity Energy and regulation on design & description of labels in its Annex.

<u>Directive 2010/31/EC</u> deals with Energy Performance of Buildings. In order to comply with this Directive, Kosovo has adopted and approved AI on Energy Auditing of Buildings.

EU has adopted in 2012 the <u>Directive 2012/27 EC</u> which is expected to be transposed at Member States legislation.

<u>Important Note:</u> Present Law on Energy Efficiency does not foresee the establishment of EE Fund, therefore it is a prerequisite to have establishment of EE Fund included in the first review or amending of this law!

# National Energy Efficiency Action Plan (NEEAP)

In September 2011 have adopted and approved both:

- 1. Long term NEEAP 2010-2018, and
- 2. First (1st) midterm NEEAP 2010-2012.
- 3. Second (2<sup>nd</sup>) midterm NEEAP 20113-2015 is drafted

Long term NEEAP foresees energy savings in the level of 9% of total energy consumption by the end of 2018 while First short term NEEAP foresees energy savings at the level of 3% by the end of 2012.

Reviewed Final Draft Report of the First short term NEEAP is finalized and ready for comments by all relevant institutions as well as by EnCS in Vienna. Forecasted achievements are not fully accomplished with implemented projects during the period 2010-2012. Energy savings achieved are reported to be at the level of 2.6 % instead of 3%.

MED/KEEA has also finalized Draft Second NEEAP 2013-2015, where are foreseen additional 3% of energy savings within this period of time.
