- Demonstrated skills in keeping accounts and making financial transactions, in preparing various financial monitoring reports in a timely manner;
- Computer literate. Good knowledge of MS Office applications. Other software are an advantage;
- Be fluent in Albanian and English;
- Excellent communication and team working skills
